3.1 RECOMMENDATIONS & PRECAUTIONS FOR USE	<ul style="list-style-type: none">• It's important that the end-user in conjunction with a Doctor or Physiotherapist test the compatibility of the adhesive with the patients (subject) skin for potential irritation.• It's important that when the product is applied to the subject, the Physiotherapist used the proper amount of tension to the body area and does not apply the product too tight where the subject is not comfortable and there is a reduction of blood circulation in the affected area.• Excessive direct adhesive contact to the same taped area may lead to human skin breakdown over time. If this occurs, it is recommended to use a thin foam layer of Underwrap to protect skin structure.• The product is not sterile and is only intended to be used on humans externally. The products are not designed as a surgical tape product and should not be used as such.• If gaps and wrinkles occur during the taping application to the body, this may lead to skin blisters. It's recommended to keep tape product smooth and wrinkle/gap free for maximum comfort.• Do Not rip tape off skin after use, this can cause pain and discomfort. It is recommended that a specialized tape cutter or a common bandage safety scissors are used to remove tape from the skin or foam Underwrap layer.
